Nieding made a motion to pay the bills. Leimbach seconded the motion. Nieding, Northeim, and Leimbach voted to accept the motion.

John Schmalz, Zoning Inspector, submitted 5 permits, consisting of 4 sheds/barns and 1 pool. A letter was sent to Thomas Burger a property owner on Gore Orphanage because of complaints of debris accumulating around his garage; letter told him to stop any non-residential use of his property and gave information about a conditional use permit. The ZBA held a hearing for the Olympic Outing Club for variances for up to 10 new cottages in the flood plain; this was approved. The ZBA also approved a front yard variance for a wrap-around porch for the Rennie residence on Vermillion Road.

The bids were opened for the Mapleview OPWC Project. Three bids were received. DL Smith at \$99,524.50, Denes Concrete at \$118,819.50, and Herk Construction at \$113,466.56. Trustee Northeim will take these bids to the Engineer's office for review.

Scott Schmalz, Labor Superintendent, reported that the county tar & chip program should be starting in a week or so. The Baumhart/Middle Ridge Road project will be starting in July and will last at least 2 months. There will be traffic detours. The grant for road signs has been submitted and we should know about July 14, 2017 if we received the grant. The old salt shed will come down this week.

In old business, Leimbach reported that the township received \$1,616.14 in Lorain County Solid Waste Grant money and he suggests purchasing some insulated shopping bags and luggage tags for the BHA to give away at the township centennial celebration. The total for 140 of each would be \$1,610.23.

Leimbach made a motion approving the above purchase at a cost of \$1,610.23. Nieding seconded the motion. Northeim, Leimbach, and Nieding voted to approve the motion. 20170605-02

Leimbach also reported that he spoke with ODOT about them possibly planting some trees around the Route 2/ Baumhart interchange. Has had no response back at this point.

Nieding spoke with the Engineer's office about residents putting items for sale in the road right-of-way on county roads. The Engineer's office said the resident should request permission to do so, or should keep items beyond the road right-of-way.

Northeim discussed the sign for the Township Meeting Hall and it was decided that no year would be put on the sign.

Fiscal Officer Marsha Funk reported on the two OPWC loan repayments, West River Rd at \$2082.50 and Candy Lane for \$1315.17.

Leimbach made a motion authorizing the township to buyback a recently purchased cemetery lot from Colette Frederick. Nieding seconded the motion. Leimbach, Nieding, and Northeim voted to accept the motion.

From the audience, the BHA wanted clarification on the new sign the BHA wants to erect. The Trustees said that their sign could be put below the existing township sign. They also thanked Scott Schmalz for putting up the roadside flags.

Leimbach said he received many compliments on Memorial Day about the neatness of Rugby Cemetery.

A resident from Greystone Dr was upset because their neighbor has 2 goats; they requested that the

In new business, Northeim spoke with Callihan Electric about the lighting at the Pavilion. Nieding is going to get another estimate.

S Schmalz will be getting a few estimates to reside the township garage; the existing steel siding will no longer hold paint.

The 2018 Budget Hearing will be held on July 10, 2018 at 6:45 pm. This had already been advertised.

Leimbach made a motion to approve the Fire Contract with the City of Vermilion for 7/1/17 through 6/30/18 at a total cost of \$27,387.68. Nieding seconded the motion. Nieding, Northeim, and Leimbach voted to accept the motion.
